Overview

This document contains information for an individual to apply for a VFH Driver's Licence in the City of North Bay.

North Bay Police Services Board By-Law No. 26/20 Vehicles for Hire and Private Transportation Company Vehicles regulates taxicabs, limousines, and private transportation companies in North Bay. As per this bylaw, private transportation companies are required to be licensed to operate in the City of North Bay.

You need a licence from the North Bay Police Services Board to operate a vehicle for hire in the City of North Bay if you drive a taxicab, limousine or private vehicle for hire. A VFH driver's licence is valid for one (1) year.

Your licence will expire annually on the anniversary of the date that the licence was first issued. A renewal notice, identifying any documents required to renew the licence, will be mailed to the address on file.

If you fail to renew your licence within 90 days of the specified renewal date, your licence will be cancelled and you will have to reapply.

To apply, please provide this completed form and the following required documents.

Complete Section 1 and 3 of this form. Section must be completed if you are applying for a VFH to drive a taxi.

Step 1a: Prepare Documents

Prepare an application by obtaining required documents and completing required forms.

All Applicants

The following documents and completed forms must be provided:

- VFH Driver's Licence Application Form
- In the case of a limousine driver or private vehicle for hire driver, additional proof that the driver has held a class G Ontario driver's licence for a minimum of three vears
- If a licence applicant is born outside of Canada, proof of citizenship, landed immigrant status and/or a valid work permit
- Ontario Ministry of Transportation Driver's abstract. The document must no older than 30 days from the date of licence application
- Criminal Background Check(s). Documents must be no older than 60 days from the date of licence application. Applicants residing outside the jurisdiction of North Bay are required to have their criminal record check completed by their local Police Service.
- With every application for renewal in the years that a police record check is not required, a sworn affidavit stating that the police record check on file has not changed and that there are no new charges or convictions, subject to section 9.1(12) of the bylaw.

Step 1b: Submit Application

Please note that incomplete applications will not be processed.

Once your application submission is complete, please deliver it to Traffic Services at North Bay Police Service Headquarters during business hours along with the applicable fees.

Notice of Collection Statement
