# Armed Forces Day events to take off in 2019

Mayor Al McDonald enjoys being part of community events but Armed Forces Day is extra special.

You see, the mayor was born on a military base in France and grew up an Army brat traveling from Goose Bay, Newfoundland/Labrador in the east to Comox, British Columbia in the west.

"Armed Forces Day to me is I have watched the sacrifice my dad made in the military, I have watched the sacrifice women and men make here because we have such a history here with the base so it is an opportunity just for us to say 'thank you,'" said McDonald.

"These men and women put their lives on the line for our country, we are proud of them as peacekeepers."

McDonald was among a handful of military and municipal dignitaries on hand this morning at City Hall to officially launch Armed Forces Day.

On Wednesday, June 12th North Bay will celebrate Armed Forces Day at the North Bay waterfront once again. This year the Snowbirds and the CF-18 demonstration event will highlight the day.

Canadore President George Burton will play a key role in helping make the event happen. Burton is one of a handful of local honourary colonels who help to raise funds to finance the high profile event.

"There is quite a large group of people which make this happen every year and you must remember it is a community wide event so we have a great team at the base," said Burton.

"We involve all other emergency services and a great group of volunteers."

Burton expects they will have more Armed Forces Day announcements coming soon.

"We are still looking for a surprise or two and we will confirm as we get closer to the date. Again we are competing for assets to come to North Bay. But all the teams that come into North Bay leave with a positive impression and each year they want to come back.

Colonel Mark Roberts, the 22 Wing Commander, this will be his fourth Armed Forces Day in North Bay.

"It is special, it signifies how welcome we feel here living in the community and really the outstanding support we have seen for decades from the city of North Bay," said Colonel Roberts.

"It is always a wonderful time. Anytime you can share an event like this with the families, bring them down and see all the static displays, have some hot dogs, hamburgers and see a world class display of military expertise."



Recommendation: Information Item

As the Board is aware, the issue of Rideshare businesses such as Uber has surfaced in the city with companies looking to establish operations locally.

We are anticipating a review of our current taxi by-law in May of this year with the intention of addressing Rideshare businesses. The issue was recently the subject of a court challenge in the Greater Toronto area as the city attempted to block Uber from operating within their jurisdiction.

The court sided with Uber stating that the city's taxi by-law had not kept up with the changes in modern technology. That decision may have an impact on our by-law review taking place later this year.

Please find attached a memorandum from Sergeant Warner addressing the issue and his understanding of the court decision in Toronto when applied to our current taxi by-law.

I recently reviewed the information relating to a recent court decision in Toronto surrounding the city's attempt at seeking an injunction to stop Uber from operating in the City based on the fact that the business was operating a 'taxi company'.

The court ruled that there was no evidence to suggest Uber was operating as a 'Taxi company 'as defined by the City's current by-laws. The court further suggested that the city had the authority and power to regulate Uber or Rideshare businesses within the city and that the matter should not have ended up in court.

Under the Toronto Taxi By-Law a 'Broker' is defined as accepting calls for rides. Since Uber does not accept 'calls' it was not considered to have triggered the licencing by-law. Uber is simply a platform on a mobile APP that connects drivers and passengers. There are no 'calls' to Uber and Uber does not dispatch rides. The argument was simply that the City by-law had not kept up with the changing technology.

When I reviewed our By-Law NO 2/97 I note that the definition of Taxi includes the phrase " Which contains or is dispatched by radio or any other telecommunications device within the Uber does not dispatch cars or drivers to go anywhere. It simply links available Citv." drivers with passengers through an online platform. The driver decides which passengers they want to pick up and there is no dispatching involved. The connection is made directly between the driver and the passenger.

Like Toronto, we also list a 'Broker' as a person or company that accepts calls in any manner for taxicabs that are used for hire. Uber does not accept calls. They simply are a link between the available driver and passenger who find each other through the mobile APP.

I am confident that a Rideshare platform similar to Uber does not currently fall under our

Taxi By-law with the definitions we have in place. It would be up to City Counsel to enact regulations around Rideshare businesses that are looking to operate in the City.

Based on the court decision in Toronto and the definitions in our current by-law, I don't believe that Uber and other similar Rideshare programs would fall under the jurisdiction of our service.

I am writing as a driver both full and part time since 1971, a driver owner since 1998and a stand partner since 2014.

Taking only my personal knowledge of the ride share, I believe that if they are CHARGING for transportation between point A and B. They are TAXIS. They are dispatched, TAXI.

Competition is healthy, but look at the Taxi By-Law it limits competition. Meters with Rate set by City, with no clause to bid .They can do what they want, the price they want, today \$1.00 tomorrow \$50.00. ..They say there is a Criminal records check, not statement of annually but we require this annually, By-Law.

There is no statements of the Quality of Insurance by ride share, TAXIS require \$2,000,000 with the city being a co insured, at our expense. Cost 7 to 10 thousand dollars.

They advertise for drivers who apply are said you are now a ride share driver, Licence fee?? Taxi annually, They use there personal vehicle, Full safeties 3 times a year, TAXIS by By-Law.Y10 year old or less vehicles ???Taxis by BY-Law. Limited number of units, they can have 500 ride share drivers/vehicles NO licence or number control or size, TAXIS by BY-Law. Ability for NBPS, to inspect TAXIS at any time as well as stop and search without warrant, By-Law.

I implore the 2 governing bodies to VERY carefully review this request to have Ride Share available. That the safety of our Citizens are carefully thought out, that controls are in place to stop such things as Joe Blow pulling up, say im Ride-Share ill take you and they are in no way associated with any Ride-Share company



"Today's outcome is a great win for the 5,000 drivers who need this flexible earning opportunity to make a living, and the 300,000 riders who rely on them to move around our great city," Ian Black, general manager for Uber Canada, said in a statement.

"We are grateful for all the support we've received from Torontonians and will continue to work in their best interests."

Uber applied for a taxi brokerage licence through the city earlier this year, but didn't apply for a limousine licence.

Toronto Mayor John Tory has said new technologies such as Uber's are here to stay and the city must figure out a way to work with them.

Taxi drivers have been vocal in their opposition to Uber, and roughly 500 recently staged a noisy protest outside Toronto City Hall.



## City given a rough ride in Uber court case

The City of Toronto's effort to shut down all of Uber's operations received a cool reception Monday as a judge repeatedly questioned whether the city should even be in court asking for help.

"This is easily resolved with a wave of a drafting wand," Mr. Justice Sean Dunphy of the Ontario Superior Court of Justice said to city lawyer Michele Wright as she wrapped up her submissions on the first day of a three-day hearing. "Why should we be arguing about this if it just takes the will of the politicians?"

The city argues that Uber is operating an illegal taxi and limo brokerage because the California-based company picks its drivers, links them with passengers through a smartphone app, has the power to suspend or dismiss drivers, and even collects the fares.

"If it looks like a duck, quacks like a duck, you should call it a duck," Wright said.

Wright noted that Uber has many operations – from the taxi service that dispatches municipally licensed drivers in municipally licensed vehicles, to the UberX application which has ordinary people driving their own personal cars to ferry people around, at a much lower fares.

Uber estimates that by year's end it will have as many as 15,000 people driving for its UberX application in Ontario, with the majority in Toronto.

She tried to shoot down Uber's argument that it is merely a passive player in the transaction and not a taxi brokerage, only linking drivers and passengers through a smartphone app. Uber, which has operated here since 2012, says it does not directly accept any calls or requests, leaving it up to drivers to decide, what rides to takes.

But Dunphy interrupted Wright several times, each time with the same point.

"The question is not whether you have jurisdiction to regulate," said Dunphy. "My question is whether you have exercised that jurisdiction. Is it my job to fill in the gaps of the legislation?"

He conceded that regulating the taxi industry is complicated and complex and it is difficult to ensnare the thousands of the illegal drivers – arguing it would be easier to nab "the Godfather."

Dunphy noted that Mayor John Tory (open John Tory's policard) has indicated that he wants to see Uber regulated, repeating his view that such rules may be better left to elected officials to set. "This (injunction application) doesn't regulate it, this extinguishes it," he said.

"If you are successful in your application, the outcome is not to go get a licence," Dunphy said "They can't get a licence. It doesn't fit in your model."

Wright, pausing slightly, argued that the city believes strongly that there are basic principles to be articulated, including the scope and the ability of the city to regulate this industry.

Dunphy also questioned whether Uber could be considered a taxi brokerage – noting a maitre d'in a restaurant might find a taxi for a customer, but does that make him a taxi brokerage.

Similarly, he said Bell — the telecom giant — which facilitates the hailing of cabs either by phone or smartphone app, is also linking drivers with passengers, so would it be considered a taxi brokerage, too?

Wright replied that the restaurant staffer is not being paid to hail the cab, unlike Uber, who receives remuneration for its work.

Uber's lawyer Julie Rosenthal began her arguments late Monday, saying that the city's regulatory scheme is triggered by accepting calls or requests for rides.

Because Uber, the company, doesn't accept calls, it doesn't trigger the licensing scheme, she said. "The provision of the municipal code has not kept up with new technology," she said. "It is not for the court to amend the municipal code. It's for the legislators."


Uber has consistently argued it is not a taxi company, but rather a technology company and has therefore refused to apply for the brokerage licence.

Only last month, with the court hearing looming and Mayor Tory calling on all parties to find a way to coexist, did Uber file an application, which is still under review, for a brokerage licence.



# Uber cheers Ontario court ruling but remains shut out of Vancouver

"This decision means that you can continue to access safe, reliable, and affordable rides through the Uber platform," Ian Black said in a statement. "We also hope that this decision helps further pave the way for ridesharing regulations and we're excited to continue our work with Mayor [John] Tory and Toronto City Council."

Justice Sean Dunphy concluded that the city has not proven that Uber is carrying out a taxi or limousine service and therefore doesn't fall under these municipal regulations. He dismissed the city's application for an injunction.

The situation in B.C. isn't nearly as clear.

Last month, the City of Burnaby advised Uber that it's ineligible for a business licence.

Uber has also encountered resistance from the provincial regulator. In 2012, the B.C. Passenger Transportation Board banned Uber's ride-sharing service.

In 2014, four B.C. taxi companies launched a B.C. Supreme Court action seeking an injunction against Uber relaunching its business in Vancouver.

It remains to be seen what impact the Ontario Superior Court ruling might have on B.C. judges who might be faced with similar disputes between Uber and regulatory authorities.

This year, the City of Vancouver extended its moratorium on new taxi licences as a Vancouver Taxi Roundtable, comprised of various stakeholders, is discussing how the business should proceed in the city.
