#### Statistical Reports

The Deputy-Chief, presented the Condensed Monthly Statistical and Revised Statistical Reports for the month of November 2016 (Revised); to the Board. Following the trend, there is an overall increase in 2016 in Police Activity and Calls for Service, and a decrease in the number of criminal offences. There were 97 motor vehicle accidents investigated. Fifteen of these accidents involved injuries with 10 persons sustaining injuries. There has been a 10% overall reduction in sexual assaults and a 5% drop in criminal offenses. The police activity increase of 90 calls per month includes approximately 8 calls per day more for the mobile crisis unit and 4 calls per day pertaining to domestic violence.

Questions with respect to local drug availability and usage of particular illegal drugs were discussed and answered by the Chief and Deputy Chief.

The Deputy shared that Drug Awareness Workshop is planned for within a month involving community partners and an internal local expert on Fentynal.

#### **ROBYN COLVIN**

On the 13<sup>th</sup> of July, 2016, at approximately 2 am, the North Bay Police Service was contacted regarding a suicidal woman near the Lake Nipissing access point of Thompson Avenue. A witness reported that she could hear a female in the water screaming for help. The witness also relayed the fact that she had observed a purse with empty pill bottles and a glass of beer near the water's edge.

Upon arrival to that location, officers observed a female who was in the water approximately 150 metres from shore. Constable Adair removed his duty belt and vest and entered the lake to render assistance. As he approached, he called out to have the person come towards him. The woman replied: "I can't. I can't hold her. She's slipping away." It was at that point that he realized that Robyn Colvin, the witness who had contacted police, was in fact in the lake attempting to rescue the suicidal woman.

Constable Adair quickly attended their location and took hold of the drowning woman. This person was unresponsive and unable to support herself. Robyn Colvin, exhausted from her ordeal, was now able to catch her breath, regain her strength and was able to continue to assist with bringing the distraught woman to shore.

Once they were out of the water, paramedics took over and transported the woman to the North Bay Regional Hospital. It was later found that she had taken a large quantity of anti-depressants along with some alcohol. She fortunately made a full recovery.

Robyn Colvin's timely response and selfless actions are truly commendable and ultimately saved a life that day.

Robyn Colvin is hereby awarded a North Bay Police Services Board Commendation for bravery and compassion for someone in need.

SUBJECT: Community Expression of Reconcilitation

#### Chief Devine,

On Wednesday June 11 2008, the former Prime Minister of Canada, the Right Honourable Stephen Harper, made a Statement of Apology to former students of Indian Residential Schools, on behalf of the Government of Canada. A cornerstone of the Settlement Agreement was the Indian Residential Schools Truth and Reconciliation Commission. This Commission presented a unique opportunity to educate all Canadians on the Indian Residential Schools system. It was a positive step in forging a new relationship between Aboriginal peoples and other Canadians. The Commission's intent was to establish a relationship based on the knowledge of our shared history, a respect for each other and a desire to move forward together with a renewed understanding that strong families, strong communities and vibrant cultures and traditions will contribute to a stronger Canada.

In December, 2015 Mr. Justice Murray Sinclair, Commission Chair, delivered the final report from the Truth and Reconciliation Commission to the Canadian Government. The report included 94 "Calls to Action" to redress the legacy of residential schools and advance the process of Canadian reconciliation. These "Calls to Action" were divided into two categories of Legacy and Reconciliation.

The Legacy categories included Child Welfare, Education, Language and Culture, Health and Justice. The Reconciliation categories are:

- Canadian governments and the United Nations Declaration on the Rights of Indigenous People

The Report made a suggestion that Expressions of Reconciliation could be made by communities, corporate organizations, individuals, the media and the artistic community. To date many municipalities across Canada have started reconciliation processes. Of note the City of Toronto prepared a report in April 2016 that outlined the City's response to the TRC recommendations. The City of Toronto's Summary Report identified eight Calls to Action that involved the municipality's responsibilities. The report also outlined the progress that had been made to date.

As part of the Reconciliation process in North Bay Mr. George Couchie, a former member of the police service, has lead a work group of educators, police officers and community volunteers to plan and deliver 4 Reconciliation Sessions to the residents of North Bay, Nipissing first Nation and the surrounding area. The session topics include: culture, history, residential schools and a feast or celebration. They will be hosted in a number of locations across North Bay and Nipissing First Nation.

The public are invited to attend and take part in the civic reconciliation process. The North Bay Police Service provides a service to the communities of North Bay and Callander. The City of North Bay has an identified aboriginal population of approximately 3200 citizens (6%). This figure does not include the Indigenous people who visit or reside in the City for temporary reasons associated to family, education and employment.

The North Bay Police Service is proud to have been asked to assist in the planning and presenting of the reconciliation process for North Bay and support the efforts of Chief Scott MacLeod and Mr. George Couchie. Constable Steve Chabbert has been an active and committed member of the organizing team and we are fortunate to have him as a member of our service. Attached is further information about the upcoming sessions.
