The Board's 2016 Operating Budget closed on 22Jan2017. The 2016 Budget will close in a deficit position of \$359,325.25. This deficit amount is after applying \$23,358.47 from the NEER Reserve.

As the Board is aware, the Service pays premiums to WSIB on an annual basis depending on the claim costs associated to factors such as the number of work related injuries, the severity of these injuries, how long members are off work and whether or not the employee is able to return to work through accommodation. The Service may be required to pay additional monies or receive a rebate pending the factors as mentioned above.

In 2013, the Board created a NEER reserve account where rebate money was deposited for the surplus years with the intention of paying costs associated to surcharges. The standing balance in the NEER Reserve in September 2016 was \$23,358.47. This balance includes a transfer to the reserve of \$12,662.22 completed in February 2016 for a refund received relating to 2015.

As reported to the Board at the December 2016 and January 2017 Meetings, including the costs associated to the 2016 allowance of a 2015 claim, the NBPS was in a surcharge of \$314,399.84 for accident years 2015, 2014, 2013 and 2012.

As legislation changed in 2016 in relation to presumptive PTSD; duration of claims and therefore associated costs are unpredictable; and in addition 2016 budgeting takes place in 2015 and therefore this surcharge was not budgeted for.

The surcharge of \$314,399.84 less the NEER Reserve balance of \$23,358.47 results in a deficit in the NEER reserve account of \$292,041.37.

In February, North Bay City Hall Financial Staff met with Deputy Chief Tod and myself to advise us that the police service was being allocated \$45,181.92 in expenses incurred by the City in 2016 for Insurance deductibles relating to Civil Law suit actions against the North Bay Police Service. In the past, deductible related expenses were paid under the City's Risk Management Accounts. These costs will now be allocated to and paid for by the police service.

I have been advised that insurance deductible thresholds have been increasing over the last several years as a mechanism to reduce insurance premiums for the City, which include premiums attributed to the police service.

The total deficit of \$359,325.25 is made up of net WSIB NEER surcharge of \$291,041.37; insurance deductibles increase of \$45,181.92; and \$23,101.96 additional expense in the 2016 Operating Budget. Additional expenses in the 2016 operating budget include costs associated to facilitators hired to work with staff on an efficiency project related to the requirement to move to Electronic Crown Briefs and for the development of the Board's three (3) year Strategic Business Plan.

It would be my respectful recommendation that the Board resolve to authorize the transfer of \$68,284 from the General Police Purposes Reserve account to apply against the deficit.
