Dear Chief TODD,

I am writing you today to express my most sincere gratitude to your officers who assisted us with a significant investigation.

In the early hours of June 2 2020, the Temiskaming O.P.P responded to two related home invasions/robberies where the suspects stabbed a male victim leaving him for dead in his apartment.

Early on in the investigation we believed that the suspects were residing in the City of North Bay.

This information was communicated with your police service and caught the ear of Detective Constables Christian ELIA and Haley FIELD of your Street Crime Unit.

These two officers went beyond the call of duty to help us with our investigation. I am sure they have many other tasks on their plates at the moment, however as a direct result of their actions all of our suspect were located and arrested.

Christmas Eve, 2020

(Presently staying at the Glen Garry cottages for another week of writing (I'm a novelist))

RE: Conduct of officers from the North Bay Police Service

To all whom this may concern,

I believe it was two evenings ago now since there was a call for service for a mentally ill person (me) in crisis. You were responding based on what my wife told you when she made the call for service *from Florida*. I did not know that she had called, that is until I saw a big cop and a *tree cop (he looked 7ft tall to me!)* whose name I never got (didn't ask for it - wish I had asked all of them) and a nurse standing on my front porch.

It was quite a cold night, so I invited them in – I would have, anyway. One of your officers, who handles mental health checks like this, was retiring – hopefully that's enough to identify him and the call for service.

I've never met such professional, sympathetic, *empathetic* police officers. They showed up at my door, I invited them inside, and that's where the police work began at the little cottage that I'm staying at during my visit to North Bay.

They expressed deep concern; they did so warmly, pragmatically, and genuinely were looking out for *my* wellbeing, not their own asses (pardon the profanity). The mental health officer was 50/50% on whether to take me to hospital. They made a difficult decision, and trusted me, something that I'm sure your officer's face every day, and left me here at my request. It was so nice to have them here though, if only to listen to me, which all three of them did, intently.

I was at the bottom of the barrel when they arrived, but they left me happier knowing *someone* up here cared about me and were looking out for *my* best interest. They were there to help in any way they could.

They saved my life, as did my wife, who called you from *Florida* (I know) and your officers went right into action, on the word of some woman in the states. my dear and loving wife. *Thank you* for taking her call seriously.

I just wish people could see the humanity in police officers.

Where I live, the police are awful to MI's with no sympathy other than to drive people off to the hospital with no apparent concern and just leave people there, alone, scared, not allowed to see or speak to my own wife, and – frankly – not feeling all that better after being unceremoniously dumped in the front lobby of a psychiatric hospital. Your officers, though, exhibited *nothing but concern for my safety*.

I will never forget what the North Bay Police Service did for me, and I would like the officers to be recognized for the important, lifesaving work they do, to keep us safe – no matter what we need saving from.

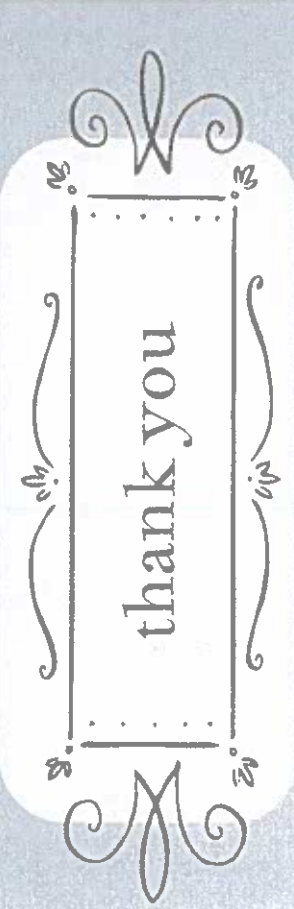
