Barrie Police Service Project Review – Body-Worn Camera Video

S/S David Goodbrand of the Barrie Police Service joined the Open session meeting via ZOOM technology. He has been instrumental with the Barrie Police Service in initiating, introducing and implementing the Digital Evident Management System (DEMS). He stated how it is changing the way data is collected and stored as well as providing the necessary police/community interaction through the use of body worn camera technology.

He recommended building the firm foundation of the DEMS before the integration of body worn cameras. S/S Goodbrand offered his assistance to the NBPS in the future implementation of this system.
