#### Statistical Reports - September 2017

Deputy Chief Tod presented the Condensed Monthly Statistical Report and the Revised Condensed Monthly Statistical Report for the month of September. He indicated a rise of 257 more calls for service from 2016. Eighty four (84) motor vehicle accidents were investigated with 16 accidents resulting in injuries to 22 persons. Within the last two days, 18 motor vehicle accidents have occurred. It is important to get snow tires installed. Overall, criminal offenses totals are down slightly, calls for service are up and police activity is down.

#### **Quarterly Report - 2017 Budget**

As required by Board resolution, the quarterly budget report as of September 2017 was presented by the Chief to the Board. Following questions for clarification, the Chief will forward a copy of the report to City Council for their information. The Chief indicated that as of 2017, the Police Services Board are as close to a balanced budget as possible.

#### **Building Facility Condition Assessment and Suitability Analysis**

The Chief provided an information report on the on the Building Facility Condition Assessment and Suitability Analysis. The history of major upgrades and repairs was outlined along with the source of funding used to execute these repairs. An assessment provided by the firm of Rebanks Pepper and Littlewood Architects outlined three (3) key reasons why the present building was not suitable to meet the ongoing needs of the Service. They also provided three (3) options: repair; expand; or replace. The most cost effective solution would be to acquire new property and replace the present building at the cost of approximately \$17 million. It is up to the Board to request the Capital Funding. The request to complete this assessment at the request, some time ago of City Hall Stagg. The Chief noted that the custodial staff are doing a good job of looking after this 47 year old building. A copy of the complete report (in excess of 200 ages) is available from Mr. Lalande, in the Office of the Chief.

#### Ministry Strategy for a Safer Ontario

The Ministry of Community and Safety Correctional Services through its Strategy for a Safer Ontario aims to standardize legislation to align police service delivery across the province. This will be accomplished by strengthening partnerships between police and the communities that they serve, enhancing consistent oversight and accountability by ensuring police services meet the needs of the community. Mandated Community safety and well-being (CSWB) will lead to a more active role by the Ministry. Municipalities will also be accountable and Police Services Boards will be mandated to develop the new plans and align their Strategic Plans with the CSWB plan. The Police Services Board is well positioned for these changes however, the municipality may not be as well prepared. This legislation will likely mean a rise in training and legal costs, and additional time requirements for Board members to undergo training with possible changes to board composition. Now in Second Reading, this Bill is expected to be implemented, for the most part in 2019.

#### 2016 Annual Report on Policing in North Bay and Callander

The 2016 Annual Report on Policing in North Bay and Callander was presented by the Chief and highlighted area statistics. He thanked, Insp. Rob Jerome and Aline Major for creating this document. Copy will be available on-line with printed copies being available soon.

The Chair thanked the Chief for the outstanding work of the Service.

#### **Association Update:**

The President, Peter Brunette reported that he had had the opportunity to attend the Legislature and meet and discuss with Vic Fidelli, MPP for Nipissing. He was in attendance for the reading of Bill 175, the Safer Ontario Act. He discussed the cutbacks to Health funding that impacts on policing and municipalities. Police are everyone's last resort.

The Chair thanked the President for his report.
