### **Chief and Deputy Chief Monthly Activity Report**

The Chief provided an updated as to events attended by himself and or the Deputy from October to early November. Included were: Nipissing Health System Cooperative Sub-Region Orientation meetings; inspectors Promotion Process at Canadore College; meeting with the Chair and MPP Vice Fideli; CFO Conference Speaker; CYAC Terms of Reference meeting and interviews; Gateway HUB Executive Committee meeting;

Out of town meetings included; CISO Governing Body meeting and Real Time Data Operation Centre / Business Intelligence in York Region; CACP Ecrime meeting in Ottawa; University of Toronto Munk School of Global Affairs Panel on unfounded Sexual Assaults; OPTIC Board meeting and OPTIC Annual User Group Meeting all held in Toronto; St John's Remembrance Day service; and International Cyber Crime Policing Summit in Fredericton NB.

The Chief commented on his participation at the international conference at the University of Toronto - Munk School of Global Affairs. He noted that the present form of police training is not conducive to investigating sexual assaults. More intense training is needed by officers who investigate these crimes.

### Statistical Reports

Deputy Chief Tod presented the Condensed Monthly Statistical Reports for the month of September and September Revised. He used the revised report to explain the monthly activities. For 2018 there was an increase in all three categories - Criminal Offenses, Calls for Service and Police Activity as compared to 2017. Clearance Rates for most categories were up. Ninety nine motor vehicle accidents occurred with seven involving injuries to ten persons. Of particular note is the fact that the solvency rates have increased. And, mental health cases continue to occur at a rate of at least 7 calls per day.

The intent of the program is to provide individuals with a professional or personal interest in community policing with an opportunity to acquire knowledge on various aspects of policing.

I wish to thank Patty Chabbert, the VIP of Enrolment Management, the Indigenous Student Services at Canadore College and Deputy Scott Tod, Inspector Kirk Kelusky and Sergeant Jody Dehaas from the NBPS for their work at developing this partnership of learning.

### MEMORANDUM OF UNDERSTANDING

### Between

Canadore College of Applied Arts and Technology 100 College Drive, North Bay, ON P1B 8K9

### And

North Bay Police Service 135 Princess Street West, North Bay, Ontario, Canada, P1B 6C2

On this 23<sup>rd</sup> day of November, 2018, whereas, Canadore College (hereinafter referred to as the College) and North Bay Police Service have formed a strategic alliance to enhance opportunities for Anishinabek students, families and communities to support Anishinabek student success and wellbeing; AND,

North Bay Police Service and the College acknowledge that partnership between the two parties will offer mutual benefits. The North Bay Police Service wishes to collaborate with and learn from the First Peoples' Centre about Indigenous cultures in Canada and positive efforts that the police service can provide to the community that will increase their effectiveness and understanding of the police response to the needs of the Indigenous persons in North Bay. Canadore College will provide the North Bay Police Service with knowledge and training to accomplish the short term goal of developing a better understanding of Indigenous cultures in Canada and addressing principle points of interest in the Truth and Reconciliation Report, through organization wide cultural awareness training. The North Bay Police Service will assist the College, as requested, with police expertise and knowledge to accomplish the goal of supporting students of Canadore College in their pursuit of developing a working perspective of policing in Canada and the associated knowledge, skills and abilities required to become a police service employee.

### **BE IT RESOLVED THAT:**

North Bay Police Service with Canadore College of Applied Arts and Technology, will work together to:

- Co-facilitate training for the Walk A Mile (WAM) for the NBSP, including the training of 2-4 NBPS
   Officers to become co-facilitators;
- Roll out the WAM training to the NBPS. Training will be led by a member of the NBPS and supported by the Manager of Indigenous and Business relations through the First Peoples Centre. Training will be co-facilitated by the College and members of the NBPS, including the development of a long term plan for ongoing training;
- Canadore College will offer Mental Health First Aid First Nation training to the NBPS to a
  maximum of 25 NBPS staff and other First Responders, including 2 facilitators. Additional costs
  to be incurred by the NBPS for this training would be manuals (\$1000/25 + S/H, GST), meeting
  expense nutrition breaks, lunch & venue (venue costs would be excluded if held at the
  College).

Partner to research and develop an Indigenous Restorative Justice program; enhance existing programs through student training experiences and classroom visits, develop and implement inter-professional simulation experience with the college, etc.

### Developed resources:

- Canadore College will assist in the production of marketing and recruitment materials for the Resotraive Justice program and assist in its promotion on its website and other social media platforms.
- Any IPE developed by Canadore College will be the property of Canadore College.

### Responsibilities of the Parties:

- Review the agreement and programs annually to ensure that the principle of partnership is being adhered to and that high standards are maintained in accordance with the Ontario Colleges of Applied Arts and Technology Act 2002, Indigenous Quality Assurances Standards.
- Ensure continued exploration and implementation of new initiatives.

### Terms of Agreement:

This agreement shall be in effect for a period of four (4) years. It will be reviewed annually and modified, prior to the new fiscal year (April).

Termination:

Either party may terminate this Agreement for any reason upon giving four (4) months notice.

On Friday May 18<sup>th</sup>, 2018, the North Bay Police Service received a complaint about a male entering a local residence and threatening the occupants with a weapon. The police had previously dealt with the male on several occasions; most calls were related to mental health and substance abuse.

Prior to police arrival, the male fled the scene. After speaking with the victims, the officers determined that there were reasonable and probable grounds to arrest the male suspect for multiple criminal offences.

On Saturday May 19<sup>th</sup>, 2018, the North Bay Police Service received information that the male suspect was walking in the area of Algonquin Avenue and the Bypass. Constable Hampel, of the North Bay Police Service, located the male near Greenwood and Algonquin Avenue. Constable Hampel exited his police cruiser and told the male that he was under arrest. When Constable Hampel attempted to handcuff the male, the apprehended male became actively resistant and assumed an aggressive stance towards Constable Hampel, who was alone. The suspect then ran towards Greenwood Avenue.

Constable Hampel ran after the male, caught up to him and attempted to gain control and arrest the male person. The male became very aggressive and assaulted Constable Hampel by delivering several punches in an effort to evade capture. A struggle between Constable Hampel and the male resulted in the two wrestling in a ditch.

Andy Gagne, a Principal with the Near North District School Board, observed the altercation as he drove down Greenwood Avenue. He immediately stopped his vehicle and rushed to the assistance of Constable Hampel. With great effort, the two were able to gain control of the violent male and Constable Hampel was able to restrain the violent male person with handcuffs. At this point, other members of the North Bay Police Service arrived and assisted Constable Hampel in completing the arrest procedure.

Following the arrest, the man was searched and an 8 inch "Buck" style knife was located inside his pants pocket. Due to carrying this concealed weapon and the incident with Constable Hampel, the male was later charged with Carrying a Concealed Weapon, Escape Lawful Custody and Breach of Probation in addition to the earlier criminal charges from the 18<sup>th</sup> of May incident.

Mr. Gagne's swift response to assist Constable Hampel was instrumental in the arrest of this male. His assistance and ability to control the male's arms allowed for Constable Hampel to effectively handcuff the male and gain control of the situation; his assistance prevented any injuries from occurring to either the officer or the male.

Mr. Andy Gagne has been a teacher for 22 years. For the past ten years, he has worked as a Principal for the Near North District School Board. Mr. Gagne has been with his caring partner, Julie Beaudoin, for 12 years.

Throughout his career, Mr. Gagne has developed a strong relationship with the North Bay Police Service. He has worked closely with both the police and other community partners to ensure that his students receive the very best services offered in North Bay.

The quick thinking and brave action of Mr. Gagne, in May, is just one example of his dedication to our community and his commitment to supporting other people in need. Mr. Gagne is a consummate professional and a man with a big heart. He is always willing to help and has a history of stopping at accident scenes to render first aid.

Mr. Gagne said that he wanted to assist the North Bay Police because he knew that in any other circumstance they would help him.
